REFERENCE Note No: SIDS DOCK/Assembly7/010 (2023) – Seventh session of the SIDS DOCK Assembly, 25th September 2023 at 10:00 a.m. (EDT)

The SIDS DOCK Secretariat presents its compliments to the States Parties to the SIDS DOCK, and on behalf of H.E. Mr. Va'inga Tōnē, Ambassador and Permanent Representative of the Kingdom of Tonga to the United Nations and Chair of the SIDS DOCK Executive Council, has the honour to refer to the forthcoming seventh session of the Assembly of SIDS DOCK, scheduled to be held virtually, on Monday, 25th September 2023, and wishes to inform State Parties that the time convening the Assembly has been changed to start at 10:00 a.m., Eastern Daylight Time, via Telephone and Teleconference, and in the margins of the General Debate of the seventy-eighth session of the United Nations General Assembly.

The Assembly will convene on 25th September 2023, at 10:00 a.m., EDT, and the decision to change the time was taken in consultation with the President and Vice Presidents of the sixth extended session of the Assembly of SIDS DOCK, the SIDS DOCK Executive Council and the SIDS DOCK Secretariat. The Assembly was previously scheduled to start at 4:00 p.m. EDT. The change in time is to facilitate participation of State Parties from the three regions to achieve a quorum. The change in time was also necessary as there are several logistical challenges that had to be taken into consideration to enable us to achieve a smooth handover of the Bureau, and this includes revising and shortening the Draft Provisional Agenda A/7/1/Rev.2 (2023), that was transmitted on 23 July 2023. In this regard, please refer to the proposed revised Draft Provisional Agenda A/7/1/Rev.5 (2023), for the seventh session of the SIDS DOCK Assembly.

Regarding Bureau Election, State Parties will recall **Note No: SIDS DOCK/Assembly7/002** (2023) — **Bureau Elections of the seventh session of the SIDS DOCK Assembly**, was transmitted via email to the State Parties on 23rd July 2023, informing that the Assembly is to elect a President and two Vice-Presidents. The President of the seventh session of the Assembly should be elected from the AIS Region, and the Vice-Presidents from the Pacific and Caribbean Regions, respectively.
