The Small Island Developing States Dock (SIDS DOCK) presents its compliments to the Members of the Caribbean Region who are States Parties to the SIDS DOCK, and has the honour to refer to correspondence Reference: **Note No: Executive Council 023/2025– Executive Council Vacancies**, dated 4th August 2025, regarding the election of two members to the SIDS DOCK Executive Council for the term 2026-2028, scheduled to be held virtually during the ninth session of the SIDS DOCK Assembly on Thursday, 25th September 2025, 4:00 p.m. to 6:00 p.m. Eastern Daylight Time, Via Telephone and Teleconference, and on the margins of the General Debate of the eightieth session of the United Nations General Assembly.

The SIDS DOCK Secretariat has the further honour to inform that, as of this date, it has received one nomination for the two remaining Caribbean allocated seats on the Executive Council. The Caribbean Region is allocated three seats, with two seats currently being held by His Excellency Mr. Carlos Fuller, former Permanent Representative of the Permanent Mission of Belize to the United Nations whose term expires on 31 December 2025, and who has been nominated by Belize for re-election, and His Excellency Dr. Philbert Aaron, Ambassador and Permanent Representative of the Permanent Mission of the Commonwealth of Dominica to the United Nations, whose term expires on 31 December 2026.

In this regard, please be reminded that the deadline for nomination of candidates for membership to the election is **no later than 17th September 2025**. 
